All applicants must be San Diego County artists

The due date for the preliminary application is **Friday, February 17, 2012.**

You will be notified by Friday, March 2, 2012 if chosen to show at Art in the Pines.

All art shown in our event is to be nature inspired, in any medium.

The non-refundable application fee is \$25.00.

There are 3 ways in which your art may be displayed after juried acceptance:

10 x 10 Booth

The canopy and set up/take down to be supplied by the artist.

Fee: \$160.00 for 2 days

(due after acceptance)

You may display and sell original or other representations of your work. There will be no commission charged.

Open Air Gallery - OAG

Fee: \$25.00 (due after acceptance)

You will be supplied with a vertical 2' x 6' grid. You may display as many pieces as you can fit on the grid as long as each piece, including frame, is no wider than 24". We will hang, sell, and replace pieces sold (up to the original number). 3 dimensional pieces, sculpture or ceramics, will be allotted 2 1/2 foot x 2 1/2 foot tabletop space, with replacements as above. There will be a 35% commission charged on all pieces sold.

Plein Air Competition

Fee: \$25.00 (due after acceptance)

One piece to be displayed and professionally judged. Your work needs to be painted in or of Torrey Pines State Natural Reserve between March 3 and May 3, 2012. Your canvas will need to be stamped at the docent desk in the Visitor Center (available March 5). You will be given a free parking pass for one month beginning April 7, 2012.

Awards are:

1st place - \$200 plus a lifetime membership in the Torrey Pines Association (value \$1,000)

2nd place - \$200

3rd place - \$100

There will be a 35% commission charged on pieces sold.

You may choose to participate in any combination of venues. Each venue has a separate event fee.
